Operational Permits	
An <u>operational (fire) permit</u> allows the applicant to conduct an operation of a business for which a permit is required by the NC Fire Prevention Code. The prescribed duration of the operational permit is the same as the frequency of the state mandated fire inspection schedule for the given type of occupancy. The initial fee for an operational permit is waived if a construction permit of the same type has been issued immediately prior to the operational permit.

*Security deposits apply to resident and non-resident events and are returned, within 21 (no exceptions) days, after a satisfactory inspection of the facility by Town Staff.

**All applications are subject to review by the Ahoskie Police Department. Some events may require the presence of a Police Officer for security reasons. The Ahoskie Police Department has sole discretion on whether or not security is necessary for the event. With such an event, a uniformed Police officer with jurisdiction in Ahoskie must be utilized. The event security fee may change without notice. Once application is made and approved, the group will be notified of any applicable security fees. If applied, the security fees are due no later than ten (10) days prior to the event or program. Once the fee has been paid, the Amphitheater permit will be issued. If the security fees are not paid, the group forfeits their reservation. The Town reserves the right to waive fees that are in its best interest. All fees are subject to review and change.

ALL RECREATION RATES ARE SUBJECT TO CHANGE BASED ON PRICE INCREASES

Not for Profit (501 C 3) – If No Fees or admission is charged. 501 C 3 organizations plus Town staff are allowed 1 rental per year (of 1 facility) at 25% reduction as long as the facility is returned clean in good order.

Admission Fee Charges – Any group who charges admission to an event.

Commercial Use – Selling items for profit. **This will include any nonprofit group who permits the vending of any item(s) for personal profit by any 2nd party individual, group or business to which the 1st party (who is the renter) either allows, or sells space to, for the purpose of making a profit. Vendors must have a privilege license from the town to sell items.**

The department also has a variety of classes and camps that change from year to year. Each activity has its own fee, which is negotiated with the individual instructor, a contract is signed and the Town receives 30% of the fees collected.

*Payment in full will be required at the time of reservations. Any remaining fees will be due fourteen (14) days in advance of the rental date.

*100.00 Security Deposit/Cleaning Deposit/Key Deposit is required on all facilities by all groups including 501-C-3 Non Profits which will be refunded once facilities have been inspected for cleanliness or damage by Recreation Staff member. Refunds may take up to 10 business days to process.

Cancellation made more than fourteen (14) days in advance will result in a refund of fees less the administrative fee of \$25.

No refunds will be given without the fourteen day prior notice less the administrative fee of \$20.

REFUND POLICY

If the Recreation Department cancels a trip, reservation, program, class or rental, a full refund will be issued.

An Administrative Fee of \$25.00 will be charged for all building reservations, programs, classes or rentals cancelled by those who registered for a class or activity, or who paid a Building/Facility rental fee.
